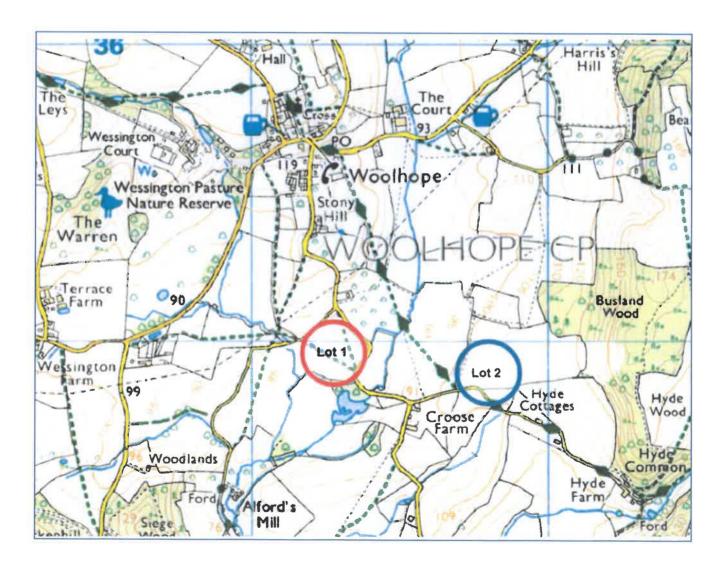

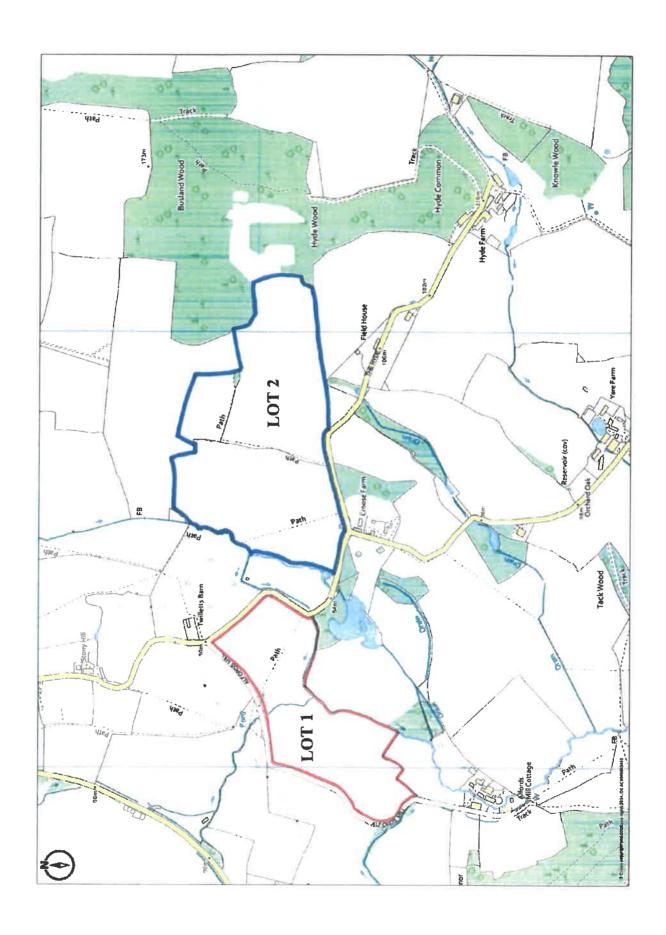


Lot 2 is situated close to Lot 1 and also has the benefit of extensive roadside frontage to the southern boundary.
